- ✓ A purchase order or pre-payment is required to begin the video certification process. Credit Cards are accepted. (Credit card payment is required for all locations outside the U.S. or Canada.)

Individuals being trained can use their credit card and purchase directly from the website.

- ✓ The training manual will be sent immediately (3-5 Days) to the technician(s) being trained as soon as the payment is received, or a manager has scheduled the training. Please do not begin the video series until the training manual is in-hand. There is a 30-day window for completing the training that begins at the time of credit card purchase, or when scheduled by a manager. No refund is offered if an individual does not complete the certification requirements within the 30-day window.
- ✓ A special login and password are issued for each individual being trained.
- ✓ Each individual is given 24/7 video access on any Internet device. It is recommended that these training videos be viewed on a desktop monitor, as opposed to a cell phone or tablet.

- ✓ At the end of the training, each individual being trained will be invited to participate in an *optional* 30-minute live video question and answer discussion with the instructor to address any specific questions that have arisen from the video series.

- ✓ At the end of the training, the manager / supervisor of the individual being trained will receive the score of an optional online timed quiz to bring extra accountability to the training program. **The questions are not designed to be difficult**, but will ensure that all the videos have been viewed, notes taken, and studied.
- ✓ A certificate of completion will then be mailed once it has been affirmed that all of the training videos have been viewed in their entirety. (Below is a sample copy of such a certificate.)
